# TORCH RUN

The Torch Run Program has the support of multiple Local Municipal Police Departments, the Office of the Attorney General, PA Chiefs of Police Association, FOP, Department of Corrections, PA Sheriffs Association, Pennsylvania State Police, PA National Guard Counterdrug Program and the Constables Association.

The final run will be held at the Opening Ceremonies of the Special Olympics Pennsylvania Summer Games at Penn State University in State College on June 5, 2008.

Locally in Area M (Dauphin, Cumberland, Perry and Northern York Counties) the torch Run has been scheduled to coincide with the Local Area M Games held at Messiah College. This event is a one-day Track and Field and Aquatics Competition. The athletes that attend this event, do so to qualify for advancement for the Summer Games held in State College.

The Area M Torch will be run from the Lower Allen Park to the Opening Ceremonies at Messiah College on April 17, 2008. The course is a scenic 5.5 mile run (10min/mile pace) with athletes from Lower Allen Park along the Yellow Breeches to the opening ceremonies at Messiah College.

Vans will be accessible for those who choose to only run sections of the course. All of the runners and athletes will escort "The FLAME OF HOPE" into the stadium during opening ceremonies. Water will also be available along the course.

All Runners should plan on wearing their Torch Run t-shirts to the run.
